1. Introduction

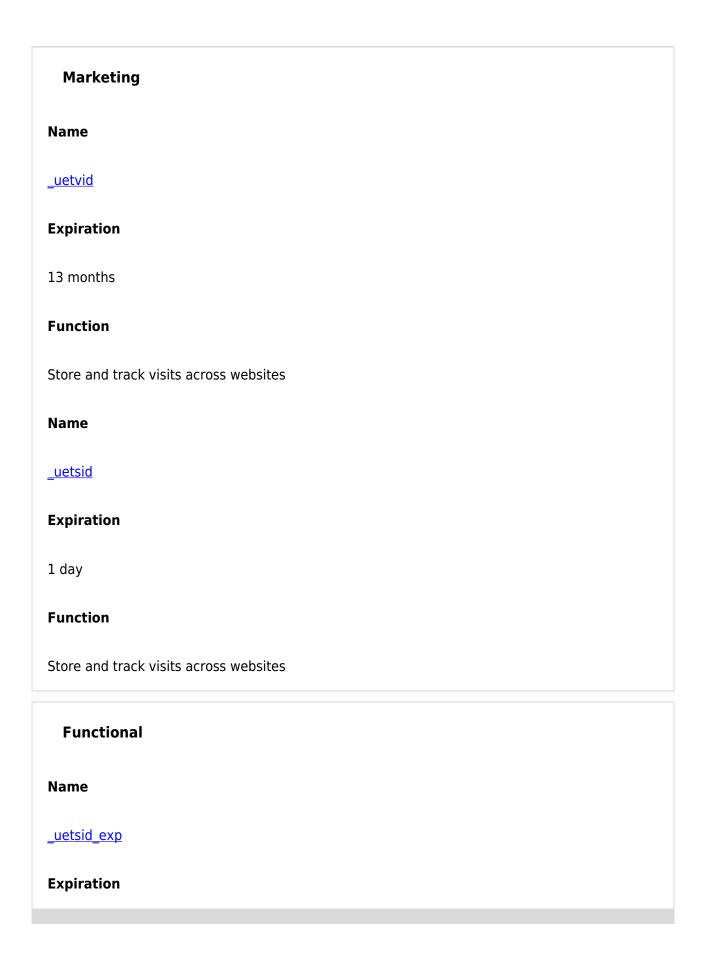
